The Resolution Plan dated 7<sup>th</sup> October 2020 submitted by M/s M/s. Longview Resources (HK) Limited, and M/s Invent Assets Securitisation & Reconstruction Private Limited was approved by the Committee of Creditors in their 27<sup>th</sup> Meeting held on 19<sup>th</sup> October 2020 and the same was put for E voting during the period from 28<sup>th</sup> October 2020 to 4<sup>th</sup> November 2020. The said resolution plan was voted in favor by 98.7% creditors in value and it was approved by Committee of Creditors with requisite majority under the provisions of the Insolvency and Bankruptcy Code 2016 and Other Regulations as specified under the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 including amendments, if any, in pursuance to Sec. 30 of the Insolvency and Bankruptcy Code 2016 and subject to the approval of the Hon'ble National Company Law Tribunal, Hyderabad Bench.

The approved Resolution Plan would be filed with the National Company Law Tribunal – Hyderabad Bench shortly for the approval of the Adjudicating Authority.
