
Dear Sir / Madam,

In terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the Company has yesterday i.e. on 8th April, 2024 at about 8:30 p.m. (IST) initiated payment of penalty amount of Rs. 8,11,116/- under protest for releasing vehicle which was detained by the GST Authority by levying penalty in contradiction with the provisions of law.

The Company provided necessary clarifications citing provisions of law including official instructions issued by GST department to the Intelligence wing for dealing with similar kind of cases. Pending adjudication of such response, in order to secure release of goods and the vehicle, the Company initiated payment of penalty amount of Rs. 8,11,116/- under protest.
