

### To The Board of Directors TURNER INDUSTRIES LIMITED

I have reviewed the accompanying statement of unaudited standalone financial Results of Turner Industries Limited ("the Company") for the Quarter ended June 30, 2023 ("The Statement"), except for the disclosures regarding 'Public Shareholding' and Promoter and Promoter Group Shareholding, which has been traced from disclosures, made by the management and has not been reviewed by me.
