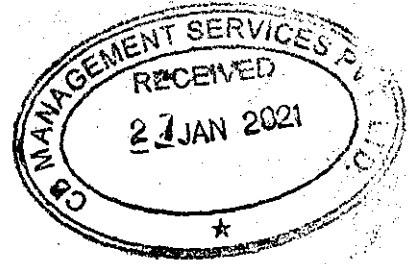



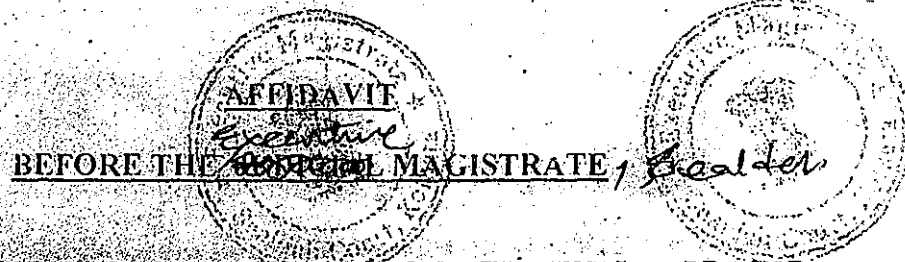

Kolkata: Sharmila Majumdar (name changed) had to take a four-month pay cut because she couldn't attend office during her advanced pregnancy. Her office doesn't allow maternity leave — an archaic rule unheard of in present-day workplaces.

You would be surprised to find out where Sharmila works: the labour department of the Bengal government, with a female chief minister at the helm.

Sharmila's plight is only a part of the drudgery that the 400-odd contractual employees have to pass through every day while preparing social security benefits and provident fund for unorganized workers enrolled with the department.

Yet, these computer-trained employees have no provident fund of their own, no standard leave rules like earned leave or medical leave other than the "14 off days" in a calendar year. They have been slogging for hours in Bengal's own sweatshops without a murmur of protest because their work contract is subject to yearly renewal.

Sample this with the government's own circular on contract employees engaged in government departments. The state finance department, in its circular issued on October 1, 2008, says: "After careful consideration of the matter, the Governor has been pleased to decide that female state government employees engaged on contract basis irrespective of their period of contract and
