Dear Sir / Madam,

Sub: Details of Forfeiture of partly paid up Rights Equity Shares of the company allotted pursuant to the Rights Issue on 12-July-2018, on which the holders thereof have failed to pay the First and Final Call Money despite reminders and final demand cum forfeiture notices dated 4th November, 2019 and 27th December, 2019 and the extensions given considering Covid-19.

Further to our intimation of forfeiture of partly paid up Rights Equity Shares as one of the item of outcome of Board Meeting held yesterday i.e., on 19.10.2020, we hereby inform you that pursuant to the Rights Issue and allotment of partly paid up Rights Equity Shares of the Company in the year 2018, the First and Final Call Money was received on only 95,04,185 equity shares out of 95,10,519 equity shares, which have been converted into fully paid up Equity Shares of the Company. The Shareholders were intimated through final demand of first and final call money cum forfeiture notices dated 4th November, 2019 and 27th December, 2019 requesting them to make the payment of Call Money within the due date / extended due date and intimating them that the non payment would attract forfeiture. After extensions given by the Board of the Company, the last date for receipt of Rights Call Money was fixed as 30-Apr-2020. Due to Covid 19 pandemic, the Board decided to be lenient on receipt of Call Money up to October 17, 2020. The receipt of first and final Call Money on 6,334 shares still remained unpaid since 10th December, 2019. The Board issued Final Demand cum Forfeiture Notices on 4-Nov-19 and 27-Dec-19 to the shareholders who have not yet paid the first and final Call Money.

The Board noted that the holders of 6,334 partly paid up Rights Equity Shares have failed to pay the balance money/first and final Call Money. Therefore, the Board of Directors at their meeting held on 19-Oct-20 took the decision to forfeit the partly paid up Rights Equity Shares on which First and Final Call Money has not been received by the company, along with the amount already paid up on such partly paid up Rights Equity Shares.

List of Shareholders who have failed to make the payment of First and Final Call Money on the partly paid up Rights Equity Shares and the number of shares are enclosed.

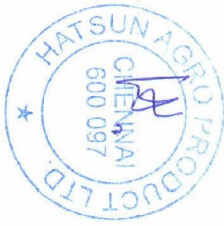
