- C. The Company has given the Public Advertisement with respect to email of Notice of Postal Ballot in English language in the newspaper "Business Standard" dated 24<sup>th</sup> February, 2024 and in Gujarati language in the news paper "Loksatta-Jansatta" dated 24<sup>th</sup> February, 2024.


