I, MukulTyagi, Practicing Company Secretary, Partner of ATG &Co., Company Secretaries, New Delhi, have been appointed by the Board of Directors of Campus Activewear Limited, ("the Company/Campus"), as Scrutinizer for the purpose of scrutinizing the postal ballot conducted through e-voting process (remote e-voting) carried out as per the provision of Section 108 and 110 of the Companies Act, 2013("the Act) read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules") read with MCA General Circular No. 09/2023 dated September 25,2023, 11/2022 dated December 28, 2022, 03/2022 dated May 05, 2022, 20/2021 dated December 08, 2021, 10/2021 dated June 23, 2021, 39/2020 dated December 31, 2020, 33/2020 dated September 28, 2020, 22/2020 dated June 15, 2020, 17/ 2020 dated April 13, 2020, 14/2020 dated April 08, 2020, and Securities and Exchange Board of India ('SEBI') vide master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023, read with SEBI Circular (s), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India in respect of resolution proposed in the Postal Ballot Notice dated February 09, 2024 in a fair and transparent manner.



Management's Responsibility:

The management of the Company is responsible to ensure the compliance with the requirements of: (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; (iii) the SEBI (Listing obligations & Disclosure Requirements) Regulations, 2015, ("Listing Regulations"); and (iv) Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India relating to e-voting on the resolution contained in the Postal Ballot Notice dated February 09,2024. The management of the Company is responsible for ensuring a secure framework and robustness of the electronic voting systems.

Scrutinizer's Responsibility:

My responsibility as a scrutinizer for the e-voting process (i.e. remote e-voting) is restricted to making a scrutinizer's report of the votes cast "in favour "or "against" the resolution contained in the Postal Ballot Notice, based on the reports generated from the e-voting system provided by National Securities Depository Limited ("NSDL"), the authorized agency to provide e-voting facilities, engaged by the Company.

Cut-Off Date

The shareholders holding shares as on the "cut off' date i.e. Friday, February 16, 2024 were entitled to vote on the proposed resolution as set out in the Postal Ballot Notice of the Company.

Remote E-voting Process

- 1. The Company has availed the remote e-voting services fromNational Securities Depository Limited ("NSDL") for providing the Members with the facility to cast their vote electronically.
- 2. The remote e-Voting period remained open from (09:00 a.m. IST) on Wednesday, February 21, 2024 up to (05:00 p.m. IST) on Thursday, March 21, 2024 and the e-voting module was blocked by NSDL thereafter.
- 3. The votes cast during the remote e-voting period were unblocked on Thursday, March 21, 2024 after the closing of the e-voting period for Postal Ballot in the presence of two witnesses who are not in the employment of the Company.
- 4. Thereafter, the details containing, inter alia, the information about equity shareholders voting 'For' and 'Against' the resolutions that were put to vote, were generated from the e-voting portal of National Securities Depository Limited ("NSDL") and based on such reports generated, data regarding the e-voting was scrutinized.
