The Appointed Date as per Scheme is April 1, 2019. The Effective Date of the Scheme is August 12, 2020. In accordance with the requirements of para 9(iii) of Appendix C of Ind AS 103, the standalone and consolidaed financial results in respect of prior periods have been restated.
