### FY 2023-24 PERFORMANCE HIGHLIGHTS

- *The consolidated income for the FY 23-24 stood at Rs. 1286 crores as against Rs.808 crores last year showing a growth of close to 60%.*
- *The EBIDTA for the FY 23-24 stood at Rs.155.17 crores as against Rs. 103.43 crores for the FY 22-23, a growth of 50%.*
- *The PBT for the FY 23-24 was at Rs.121.93 crores as against Rs. 70.45 crores for the FY 22-23 showing a growth of 73%.*
- *The PBT margin for the full year stood at 9.48% as against the 8.71% reported last year.*
- *The net profit reported for the FY 23-24 stood at Rs.85.31 crores as against Rs.60.41 crores reported in the FY 22-23 showing a growth of 41%.*
- *The gross debt for the FY 23-24 was at Rs.177 crores as compared Rs.242 crores in the FY 22-23 showing a reduction of 65 crores or around 27%.*
- *The gross debt to equity further improved to 0.35 as compared to 0.67 a year ago.*
