P.)

Mr. Kishore gupta (DIN:00014205), Managing Director & Chairman of the Company chaired the AGM.

The requisite quorum being present, Chairman called the meeting to order.

• All the Directors of the Company (including Chairman of the Audit Committee, Chairman of the Nomination and Remuneration Committee, Chairman of the Stakeholder's Relationship Committee, Chairman of the Corporate Social Responsibility Committee), M/S Piyush Bindal & Associates (Secretarial Auditor and Scrutinizer of the Company,), M/s Sanjay Kasliwal & Associates (Cost auditors of the company), M. Itisha Agarwal(Company Secretary of the Company) attended the AGM. M/s A.K. Khabya & Co., Chartered Accountant (Statutory Auditor of the Company), could not attend the AGM due to pre-occupancy, he was granted exemption by the Board.

The Chairman welcomed all the members and with the consent of the members Present, took the notice of the meeting, report of the board of Directors and of the Auditors and Standalone Financial Statements for the Financial year ended 31st March, 2023 as read.

The Chairman then delivered the speech to the Shareholders.

The Chairman informed the Shareholders that the In compliance with provisions of Section 108 of the Companies Act, 2013, Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended and applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Company had provided to the Shareholders, the facility to cast their vote electronically through remote e-voting facility provided by NSDL which had commenced on Tuesday, September 26th, 2023 (9:00 am) (IST) and ends on Thursday, September 28th, 2023 (5:00 pm) (IST), on all resolutions set forth in the Notice of the AGM.
