We write to inform you that pursuant to Regulation 10(c) of Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 ("SBEB Regulations"), the Shares Allotment Committee of the Company in its Meeting held today i.e. 6<sup>th</sup> February, 2024 have approved the allotment of 13,833 (Thirteen thousand eight hundred thirty three) equity shares of face value of Rs. 5/- (Rupees Five only) each, as fully paid-up to the eligible employees of the Company pursuant to the exercise of Employee Stock Appreciation Rights ("ESARs") by eligible employees of the Company under Prataap Employees Stock Appreciation Rights Plan 2018 ("ESARP 2018"/"Plan").

The aforesaid equity shares shall be subject to the provisions of the Memorandum of Association and Articles of Association of the Company and shall rank pari passu from the date of allotment in all respects with the existing equity shares of the Company.

Post allotment of the aforesaid equity shares the Paid-up Share Capital of the Company stands increased to Rs. 11,93,67,125 (Rupees Eleven crore ninety three lakh sixty seven thousand one hundred twenty five only) divided into 2,38,73,425 (Two crore thirty eight lakh seventy three thousand four hundred twenty five) equity shares of Rs. 5/- each.
