- 1. The Board of the Company at its meeting held on February 10, 2021 had appointed me as Scrutinizer pursuant to section 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, and all other provision as applicable, to scrutinize the postal ballot through remote e-voting process (e-voting)in fair and transparent manner in accordance with General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No.22/2020 dated June 15, 2020, General Circular No.33/2020 dated September 28, 2020 and General Circular No.39/2020 dated December 31, 2020 issued by Ministry of Corporate Affairs, Government of India (hereinafter referred "the MCA circulars").
- The Company has sent postal ballot notice electronically to all those Members whose name appeared in the Register of Members/List of Beneficiaries and whose e-mail id(s) were registered with the Company and/or their depositories as on cut-off date i.e. February 12, 2021.
- 3. The Company has engaged Central Depository Services (India) Limited (CDSL) as the service provider, for extending the facility of e-voting to all the Members of the Company.

- The postal ballot E-voting started on Monday, February 22, 2021 at 10.00 A.M.(IST) and ended on Tuesday, March 23, 2021 at 05:00 P.M (IST).
- I have scrutinized and reviewed the postal ballot remote e-voting (e-voting)
 facility through the scrutinizer's secured link provided by CDSL through its designated
 website.
- 6. The remote e-voting was unblocked by me immediately after the end of e-voting period in presence of two witnesses not in the employment of the Company and we have downloaded the E-voting report from the website of CDSL in respect of members, who voted through e-voting.
- 7. The management of the Company is responsible to ensure the compliance with the requirements of the relevant provisions of (i) the Companies Act, 2013 and the rules made thereunder including MCA circulars; and (ii) the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, relating to postal ballot and voting by electronic means.
