PROCEEDINGS OF 32nd ANNUAL GENERAL MEETINGS OF THE MOHITE INDUSTRIES LIMITED HELD ON SATURDAY, 30TH SEPTEMBER, 2023.

The 32nd Annual General Meeting (AGM) of the members of M/s. Mohite Industries Limited was held on Saturday, 30th September, 2023 at R S No 347, Ambapwadi Phata, P. B. No.1, Off. NH 4, Vadgaon, Tal. Hatkanangale, Dist. Kolhapur, 416112.

As per pre-determined time the AGM commenced at 11.00 A. M. After confirmation of quorum, members present at the meeting choose Mr. Shivaji Mohite, Managing Director of the Company as the Chairman of the meeting and he called the meeting to order. He presided over the Meeting.
