Key Performance Highlights

Q2FY24

- At the group level, revenue grew by 5% QoQ and EBITDA by 21% on account of seasonality in EDTech. YoY revenue grew 16%, impacted by headwinds in DA and Specialized Staffing.
- General Staffing: Added net
 ~28k headcount in H1FY24
 taking the total billable
 headcount to ~2.51 lakhs.
 Staffing revenue grew 5%
 QoQ and 20% YoY largely
 driven by BFSI and Consumer
 verticals.

Degree Apprenticeship (DA): Trainee headcount growth is net positive for the months of August'23 and September'23 driven NAPS (National bν Apprenticeship Promotion Scheme) and WILP (Work Integrated Learning Program).

Specialised Staffing: Despite headwinds in the IT industry, we have sustained revenues and profits with a diversified portfolio of captives and services companies.








Break-up of core headcount








TeamLease Group Structure
