During 2022-23, the Zero COVID policy in China and the resultant COVID related shutdown there, had resulted in a sharp contraction of demand for PVC resin in that country. On account of this, there was a spike in exports of PVC resin from China, leading to a steep fall in finished products prices in India as well as feedstock prices. In line with generally accepted accounting principles, the Group had written down the carrying value of stocks of major intermediates and finished products, to levels corresponding to the net realisable value of finished products, leading to an exceptional charge during 2022-23 in consolidated and standalone financials of Rs. 80.50 Crores and Rs. 49.80 Crores respectively.
- c) Other Equity as per consolidated and standalone financials (excluding revaluation reserve) as at 31st March 2024 was Rs. 110.78 Crores and Rs. 2677.56 Crores respectively and as at 31st March 2023 was Rs. 223.57 Crores and Rs. 2751.12 Crores respectively.
