## REVIEW AND ANALYSIS OF THE RE-CLASSIFICATION REQUEST RECEIVED FROM PATANJALI FOODS LIMITED (FORMERLY KNOWN AS RUCHI SOYA INDUSTRIES LIMITED)

It was submitted to the Board that a request dated 17<sup>th</sup> April, 2024 for re-classification from Promoter Group Category to Public Category has been received from Patanjali Foods limited (Formerly known as Ruchi Soya Industries Limited) on 20th April, 2024, pursuant to regulation 31A of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 (SEBI LODR Regulations). The Board also noted that due intimation to stock exchanges regarding receipt of such request was made on 20<sup>th</sup> April, 2024 by the Company in terms of Regulation 31A(8)(a) of SEBI LODR Regulations.

The Board reviewed the request and rationale thereof in terms of the Orders passed by Hon'ble National Company Law Tribunal, Mumbai Bench in accordance with the provisions of Insolvency and Bankruptcy Code, 2016, as attached with the request. The Board noted that during the month of March, 2024, Patanjali Foods Limited (PFL) has sold 54,02,116 equity shares of the Company and currently it holds 2,18,08,795 equity shares (being 9.70% of paidup equity capital) of the Company. While analyzing the request, the Board observed that it is short of due description in accordance with Regulation 31A(3)(a) and (b). The Board instructed the Company Secretary to advise PFL to submit complete application for due analysis by the Board.
