Pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations, we hereby inform you that the Company has received an Order from the Office of the Superintendent, CGST & Central Excise, Range I, Division IV, Indore demanding tax of Rs.0.10 crore plus interest thereon and also penalty of Rs.0.01 crore under Section 73 of the Integrated Goods and Services Tax Act, 2017, Central Goods and Services Tax Act, 2017 and MP Goods and Services Tax Act, 2017 for the financial year 2018-19 for disallowance of input tax credit due to returns filed by the suppliers after cut-off date or cancellation of GSTIN of suppliers with retrospective effect. The Company is in the process of filing an appeal against the said Order. There is no material impact on the financials, operations or other activities of the Company due to this penalty.
