(The Hon'ble National Company Law Tribunal, Ahmedabad Bench, ("NCLT"), had vide its order dated April 24, 2023 admitted the application for the initiation of the corporate insolvency resolution process ("CIRP") of Corporate Debtor ("Admission Order") in terms of the Insolvency and Bankruptcy Code, 2016 read with the rules and regulations framed thereunder, as amended from time to time ("Code"). Further, the NCLT vide an order dated July 17, 2023 has appointed Mr. Prawin Charan Dwary as the resolution professional ("Resolution Professional") for the CIRP of the Corporate Debtor ("Appointment Order"). Pursuant to the provisions of the Code, the powers of the Board of Directors of the Company stand suspended and the same have been vested with and are being exercised by the Resolution Professional)
