ORDER (Hybrid Mode)

29.01.2024: Learned counsel for the Appellant submits that the Adjudicating Authority while hearing IA No.68 of 2021 filed by the Resolution Professional for approval of the Resolution Plan, the State Bank of India, who was one of the Financial Creditor submitted that SBI wants to withdraw its consent. Learned counsel for the Appellant submits that the plan having been approved on 27.10.2020 there was no occasion for permitting the State Bank of India to withdraw from the plan. The Adjudicating Authority committed error in disposing off the application I.A. No.68 of 2021 and further directing for liquidation. Submission needs scrutiny.
