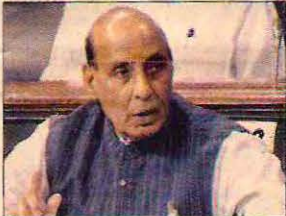

Ladakh standoff: India determined to protect its territorial integrity

However, India is determined to protect its sovereignty and territorial integrity in the face of unilateralism and aggression, no matter what the sacrifice."

Indian Army to press for expeditious disengagement at 8th round of talks

THE INDIAN ARMY is set to press for comprehensive disengagement of troops by the Chinese PLA from all the friction points in eastern Ladakh at the eighth round of Corps Commander-level talks on Friday, official sources said.

The talks are slated to begin at 9:30 am in Chushul on the Indian side of the Line of Actual Control (LAC) in eastern Ladakh, the sources said on Thursday.

Nearly 50,000 Indian Army troops are currently deployed in a high state of combat readiness in various mountainous locations in eastern Ladakh in sub-zero conditions as multiple rounds of talks between the two sides have not yielded concrete outcome to resolve the six-month-long military standoff.

The Chinese People's Liberation Army (PLA) has also deployed an equal number of troops, according to officials.

गोला थाने के थानाध्यक्ष बीएन ओझा ने बताया कि परिवार की सूचना पर पुलिस दल गांव पहुंचा और उसने युवक के शव को अंत्य परीक्षण के लिए भेजा।

उन्होंने बताया कि पुलिस मामले की जांच कर रही है।
