In terms of the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Nomination and Remuneration Committee (**NRC/Compensation Committee**) of the Board of Directors of the Company in its meeting held on Thursday, 14th March, 2024, has approved the followings:

1. <u>Allotment of Equity Shares pursuant to exercise of options under "Sona BLW Precision Forgings</u> <u>Limited Employee Stock Option Plan 2020" ("ESOP Plan")</u>

The NRC has made allotment of 5,968 (Five Thousand Nine Hundred and Sixty-Eight Only) equity shares having face value of Rs. 10/ - each fully paid-up to the eligible employee of the Company, upon exercise of the Options vested, under the Sona BLW Precision Forgings Limited Employee Stock Option Plan 2020" ("**ESOP Plan**") of the Company. The equity shares so allotted under the ESOP Plan shall rank *pari passu* with the existing equity shares of the Company in every aspect, including dividend entitlement.
