

एच-1बी वीजाधारकों के जीवनसाथी को काम से रोकने वाला आदेश वापस

वाशिंगटन, २८ जनवरी (भाषा)।

अमेरिकी राष्ट्रपति जो बाइडन ने कार्यभार संभालने के एक सप्ताह बाद ट्रंप शासन के उस आदेश को वापस ले लिया. जिसके तहत एच-1बी कार्य वीजाधारकों के जीवनसाथी को काम करने की अनुमति देने वाले एच4 वीजा पर रोक लगाई गई थी, जिनमें से ज्यादातर अत्यधिक कुशल भारतीय महिलाएं हैं। एच-4 वीजा एच-1बी वीजाधारकों के पति/पत्नी या 21 साल से अधिक उम्र के बच्चों को जारी किया जाता है। उच्च कौशल वाले एच-1बी वीजाधारकों में बड़ी संख्या भारतीयों की है।

एच-1बी वीजा एक गैर-अप्रवासी वीजा है जो अमेरिकी कंपनियों को कुछ व्यवसायों के लिए विदेशी श्रमिकों को नियुक्त करने की अनुमित देता है. जहां सैद्धांतिक या तकनीकी विशेषज्ञता की

वापस ले लिया गया है।

अमेरिका के पूर्व राष्ट्रपति बराक ओबामा के कार्यकाल के दौरान एच-1बी वीजाधारकों के जीवनसाथियों को रोजगार की इजाजत दी गई थी।

ट्रंप प्रशासन ने सत्ता में आने के तुरंत बाद 2017 में इस नियम को रद्द करने की घोषणा की। हालांकि, रिपब्लिकन पार्टी के नेतृत्व वाला ट्रंप प्रशासन अपने शासन के चार वर्षों में इस प्रक्रिया को पूरा नहीं कर सका। राष्ट्रपति चुनाव अभियान के दौरान बाइडन ने ट्रंप प्रशासन के इस फैसले को वापस लेने का वादा किया था।

अमेरिका में भारतीय मूल के डॉक्टर ने महिला को गोली मार कर खुदकुशी की पुलिस ने कहा कि शुरुआत में कई लोगों को

अमेरिकी के टेक्सास राज्य की राजधानी ऑस्टिन के एक चिकित्सा कार्यालय में कैंसर से पीड़ित भारतीय मूल के 43 वर्षीय बाल रोग विशेषज्ञ ने कुछ लोगों को बंधक बनाने के बाद एक महिला डॉक्टर की गोली मारकर हत्या करने के बाद ख़ुद को भी गोली मार कर खुदकुशी कर ली। पुलिस ने बताया कि हथियारबंद व्यक्ति की पहचान डॉ भरत नरुमांची के रूप में हुई है जो कैंसर से पीडित था।

सीएनएन की खबर के अनुसार, ऑस्टिन पुलिस विभाग ने प्रेस विज्ञप्ति जारी की। जिसमें बताया गया कि पुलिस को मंगलवार को कॉल के जरिए सुचना मिली कि एक व्यक्ति 'चिल्ड्रेन्स मेडिकल ग्रुप' (सीएमजी) के कार्यालय में हथियार लेकर घुस गया है और उसने कुछ लोगों को बंधक बना लिया है।

बंधक बनाया गया था लेकिन बहुत से लोग चंगुल से निकलने में कामयाब हो गए और हमलावर ने कैथरीन डॉडसन नामक एक बाल रोग विशेषज्ञ को छोड़कर अन्य को जाने की अनुमति दी।

पुलिस ने कहा कि हमलावर के चंगुल से भाग निकलने में कामयाब रहे लोगों ने घटनास्थल पर अधिकारियों को बताया कि व्यक्ति के पास पिस्तौल है जो शॉटगन जैसी दिख रही थी।

पुलिस को डॉ. नरुमांची और डॉ. डॉडसन के बीच किसी प्रकार के संबंध की जानकारी नहीं मिली है।

पुलिस विभाग की ओर से जारी विज्ञप्ति के अनुसार, 'ऐसा लगता है कि डॉ. नरुमांची ने डॉ. डॉडसन की हत्या करने के बाद खुद को गोली मार ली।' घटना की जांच जारी है।

विदेश नीति के केंद्र में होगी जलवायु परिवर्तन चुनौतियां : बाइडेन

वाशिंगटन, 28 जनवरी (भाषा)

अमेरिका के राष्ट्रपति जो बाइडेन ने बुधवार को कहा कि जलवायु परिवर्तन की चुनौतियां उनकी राष्ट्रीय सुरक्षा और विदेश नीति का केंद्र होंगी। बाइंडेन ने इस चुनौती से निपटने के लिए बुधवार को कई शासनादेशों पर हस्ताक्षर किए। इन चुनौतियों को उन्होंने इस युग का सबसे बड़ा खतरा बताया है।

बाइडेन ने वाइट हाउस में कहा, 'आज मैं जिस शासनादेश पर हस्ताक्षर कर रहा हुं, वह यह भी स्पष्ट करता है कि जलवायु परिवर्तन हमारी राष्ट्रीय सुरक्षा और विदेश नीति के केंद्र में होगा।' बाइडेन ने पूर्व विदेश मंत्री जॉन केरी को जयवायु परिवर्तन से जुड़े मामलों के राष्ट्रपति के विशेष दूत के लिए नामित किया है।

हिंदू देवी-देवताओं पर कथित आपत्तिजनक टिप्पणियों के मामले में मध्य प्रदेश हाई कोर्ट ने हास्य कलाकार मुनव्वर फारूकी और एक अन्य प्रस्तोता नलिन यादव की जमानत याचिकाएं गुरुवार को खारिज कर दीं। साथ ही अदालत ने अपने आदेश में कहा कि देश में अलग-अलग तबकों के बीच सौहार्द्र और भाईचारा बढ़ाने के प्रयास किए जाने चाहिए।

हाई कोर्ट के इंदौर पीठ के न्यायमूर्ति रोहित आर्य ने याचिकाओं पर सुनवाई के बाद गुरुवार को जारी फैसले में दोनों आरोपियों की याचिकाएं खारिज करते हुए कहा, 'मुकदमे के गुण-दोषों को लेकर संबंधित पक्षों की दलीलों पर अदालत कोई भी टिप्पणी करने से बच रही है। लेकिन मामले में जब्त सामग्री, गवाहों के बयानों और (पुलिस की) जांच जारी होने के चलते फिलहाल जमानत याचिकाओं को मंजुर करने का कोई मामला नहीं बनता है।'

नागपुर, 28 जनवरी (भाषा)।

बंबई हाई कोर्ट की न्यायाधीश ने एक फैसले में कहा है कि पांच साल की एक बच्ची का हाथ पकड़ना और उसके समक्ष अपने गलत इरादे जाहिर करना बाल यौन अपराध संरक्षण (पॉक्सो) कानून के तहत यौन उत्पीड़न

न्यायमूर्ति पुष्पा गनेदीवाला के एकल पीठ ने 50 वर्षीय एक व्यक्ति की अपील पर 15 जनवरी को अपने फैसले में यह टिप्पणी की थी। इस व्यक्ति ने पांच साल की एक बच्ची के यौन उत्पीड़न करने और छेड़छाड़ करने के आरोप में दोषी ठहराए जाने संबंधी सत्र अदालत के फैसले को चुनौती दी थी।

न्यायाधीश ने इस फैसले के चार दिन बाद पॉक्सो कानून के तहत 39 वर्षीय एक व्यक्ति को यह कहते हुए बरी कर दिया गया था कि बच्ची की छाती को उसके कपड़ों के ऊपर से स्पर्श करने को यौन उत्पीड़न नहीं कहा जा सकता। हालांकि, उन्हें अपने इस फैसले को लेकर आलोचना का सामना करना पड़ा है।

न्यायमूर्ति गनेदीवाला ने 19 जनवरी को सुनाए गए उक्त फैसले में 39 वर्षीय एक व्यक्ति को बरी करते हुए कहा था कि बच्ची के शरीर को कपड़ों के ऊपर से गलत इरादे से स्पर्श करने को यौन उत्पीड़न नहीं कहा जा सकता। सुप्रीम कोर्ट में प्रधान न्यायाधीश एसए बोबडे, न्यायमूर्ति एएस बोपन्ना तथा न्यायमूर्ति वी रामसूब्रमण्यम के पीठ ने बुधवार को अटार्नी जनरल केके वेणुगोपाल द्वारा यह मामला पेश किए जाने के बाद हाई कोर्ट के आदेश पर रोक लगा दी।

इरादे जाहिर करना यौन उत्पीड़न नहीं बंबई हाई कोर्ट की न्यायाधीश ने पोक्सो

कानून के दायरे को लेकर कहा

वेणुगोपाल ने दलील दी थी कि बंबई हाई कोर्ट का यह फैसला बहुत ही परेशान करने वाला है। वहीं, लिबनस कुजूर (50) को अक्तूबर 2020 में भारतीय दंड संहिता (आइपीसी) की धाराएं-354(1) (महिला की गरिमा को ठेस पहुंचाना) और 448(घर में जबरन घुसना)-तथा पॉक्सो कानून की धाराओं के तहत दोषी ठहराया गया था और पांच वर्ष के कारावास की सजा सुनाई गई थी।

न्यायमूर्ति गनेदीवाला ने अपने आदेश में कहा कि अभियोजन ने यह साबित कर दिया है कि आरोपी ने पीड़िता के घर में उसकी गरिमा को ठेस पहुंचाने या यौन उत्पीडन करने के मकसद से प्रवेश किया था. लेकिन वह (अभियोजन) आरोपी के 'यौन हमला करने' या 'इरादतन या जानबुझ कर यौन हमला करने ' के आरोपों को साबित नहीं कर पाया है।

न्यायाधीश ने कहा, 'पीड़िता का हाथ पकड़ने या उसके समक्ष गलत इरादे जाहिर करना, जैसा कि अभियोजन की गवाह (पीड़िता की मां ने देखा था), इस अदालत की राय में यौन हमले की परिभाषा के दायरे में नहीं आता है।' अदालत ने कहा कि मामले के तथ्य आरोपी की आपराधिक जवाबदेही तय करने के लिए अपर्याप्त हैं। अभियोजन के अनुसार कुजूर 12 फरवरी, 2018 को बच्ची के घर उस वक्त गया था. जब उसकी मां घर पर नहीं थी।
