Subject: Update on Implementation of the Approved Resolution Plan

We refer to our intimations dated August 11, 2023 and August 12, 2023 (read with the corrigendum dated August 14, 2023), whereby it was intimated by the Companies (*defined below*) that vide an order passed on August 11, 2023, the Hon'ble National Company Law Tribunal, Kolkata, approved the resolution plan submitted by National Asset Reconstruction Company Limited ("**Approved Resolution Plan**") for Srei Infrastructure Finance Limited and Srei Equipment Finance Limited ("**Companies**") under section 31 of the Insolvency and Bankruptcy Code, 2016 ("**Code**").

Subsequently, the Company, on instructions of the IMC, has initiated the process of making payments to various stakeholders in terms of the Approved Resolution Plan and in accordance with the provisions of the Code.

We request you to take this on record, and to treat the same as compliant with the applicable laws.
