The Company had completed the dispatch of Postal Ballot Notice dated 27<sup>th</sup> November, 2020, through email only on 30th November, 2020 in accordance with the guidelines prescribed by the Ministry of Corporate Affairs ("MCA") for holding general meetings/conducting postal ballot process through E-voting process [vide General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020 and General Circular No. 22/2020 dated June 15, 2020 ("MCA Circulars")]in view of COVID-19 pandemic, to all such Members whose names appeared on the Register of Members / list of beneficiaries on 27th November, 2020 (cut-off date).

The assent or dissent of the Members were sought for passing of 1 (one) special business, so as to reach the same to the Scrutinizer on or before 5:00 p.m. on 30th December, 2020 (the last time and date fixed for remote e-voting).

The advertisement containing relevant details as required by the Companies (Management and Administration) Rules, 2014 including any statutory modification or re-enactment thereof for the time being in force, was published on 1stDecember, 2020 in Financial Express, English and Aajkal, in Bengali, having electronic edition.

The Board of Directors of the Company at their Meeting held on 10th November, 2020 had approved the Notice convening an Extra-Ordinary General Meeting (EGM) on December 21, 2020 and appointed Mr. Asit Kumar Labh (Membership No. 32891; C.P. No. 14664), of c/o M/s A. K. Labh & Co., 40, Weston Street, 3rd Floor, Kolkata – 700 013 as the Scrutinizer for conducting the Postal Ballot and E-voting process in a fair and transparent manner.

However considering restrictions associated with COVID-19, the mode of exercising the approval by the Members was proposed to be changed from EGM to Postal Ballot (through E-voting). Accordingly the Board of Directors of the Company by way of passing resolutions by circulation [u/s. 175 of the Companies Act, 2013 (the Act)] on 27th November, 2020, approved obtaining the Members' approval through Postal Ballot (through E-voting) pursuant to Section 110 of the Act and MCA Circulars, as aforesaid, with due intimation to the Stock Exchanges.

According to the provisions of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 including any statutory modification or re-enactment thereof for the time being in force and other applicable provisions, if any, Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in accordance with the guidelines prescribed by the Ministry of Corporate Affairs ("MCA") for holding general meetings/conducting postal ballot process through e-voting process vide MCA Circulars, as aforesaid, that the Company is seeking the consent of the Members to transact the below mentioned special business by way of postal ballot through remote E-voting ("Postal Ballot").

The Company had provided the E-voting facility to all its Members in order to enable them to exercise their votes electronically. The E-voting portal of CDSL for voting purpose was remained open from 9:00 a.m. on 1stDecember, 2020 to 5:00 p.m. on 30th December, 2020.
