

पुलिस ने ठगी के आरोपी को अमृतसर से दबोचा

84 दंगा पीड़ितों को फ्लैट के नाम पर टगने वाला जालसाज गिरफ्तार

1984 सिख दंगे के पीड़ितों को ठगने वाले एक शातिर जालसाज को पश्चिमी जिले की राजौरी गार्डन पुलिस ने गिरफ्तार किया है। आरोपी ने लोगों को फ्लैट के नाम पर लाखों रूपए की चपत लगायी थी। बलविंदर सिंह (62) मूलरुप से अमृतसर पंजाब का रहने वाला है। पुलिस ने इसे अमृतसर से हीं गिरफ्तार किया है। 29 फरवरी 2016 को शिवाँजी एंक्लेव, रघुर्बीर नगर निवासी सरोज ने मामले में राजौरी गार्डन थाने में शिकायत दर्ज करायी थी। उसने बताया था कि बलविंदर पाल बेदी ने 1984 दंगे के आठ पीडित लोगों को सस्ते दामों पर फ्लैट दिलवाने के नाम पर ठगा है। किसी से छह लाख रुपए वसूले गए तो किसी से साढे सात लाख। केस दर्ज होने के बाद से ही आरोपी अंडरग्राउंड था। स्थानीय थानाध्यक्ष अनिल शर्मा की टीम ने सम्बंधित एजेन्सियों से आरोपी के बारे में जानकारी जुटायी। पीड़ित लोगों से बातचीत के बाद मिले सुराग के आधार पर उसके दिल्ली के कई ठिकानों पर छापे मारे गये। इसके बाद पुलिस को पता चला कि आरोपी ने कोर्ट में बेल एप्लीकेशन लगा अंतरिम सुरक्षा हासिल कर ली है। एक एमओयू के तहत उसने पीड़ित लोगों को करींब 30 लाख रुपए लौटा भी दिए लेकिन वह पूरी रकम नहीं लौटा रहा था। इस वजह से उसकी जमानत को कोर्ट ने रह कर दिया था। आखिरकार टैक्नीकल सर्विलांस और ग्राउंड लेवल पर की गई जांच के बाद पुलिस ने आरोपी को अमृतसर पंजाब से पकड़ लिया। आरोपी ने पीड़ितों को यह बात कहकर झाँसे में लिया था कि फ्लैंट केवल दंगा पीड़ितों को ही आवंटित किए जाने हैं। बकायदा लोगों को विश्वास में लेने के लिए उसने फर्जी बस्तावेज भी बिखाए थे। खरीबढार और बेचने वाले के बीच एग्रीमेंट भी करा दिया गया था।
