## Sub: Outcome of Nomination, Remuneration and Compensation Committee Meeting.

This is to inform you that the Nomination, Remuneration and Compensation (NRC) Committee of the Board in its meeting held on 16<sup>th</sup> May, 2024 has inter alia transacted the following business:

- 1. Approved grant of 50,000 Stock Options under Employees Stock Option Plan 2018 (ESOP 2018 Scheme) to the identified employee of the company on the terms and conditions as placed before the Nomination, Remuneration and Compensation Committee Meeting.
- 2. Approved allotment of 18,000 Equity shares of Rs.10 each under ESOP 2007 scheme to the eligible employees of the Company on exercise of stock options vested in them.
