Sub: Shutdown/ Suspension of manufacturing and Plantation operations at the Company's plants due to outbreak of Coronavirus (COVID-19)

Ref: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations)

We would like to inform you that in view of the outbreak of the Coronavirus (COVID-19) pandemic, the Company is taking various measures to ensure the safety and wellbeing of all employees and is ensuring compliance with the directives issued by the Central Government, State Governments and local administration in this regard. Further, the Company has already opted for 'Work from Home' for all employees at its various offices with effect from 18th March 2020, to minimize the risk and contain the spread of COVID-19.

Further, in compliance with the directives / orders issued by local, state and central Government Authorities, and keeping in mind the safety and well-being of all the employees and stakeholders, the Company had shut down its Instant Coffee manufacturing units in India and its coffee curing division and had also suspended its plantation operations.

The Government has now notified measures to ensure that uninterrupted supply of essential foodstuffs including coffee and tea is made available to the public at this point of time and the Company has represented to the concerned statutory authorities seeking necessary permission to continue with the manufacturing operations and plantation operations, since the Company's primary products are part of this list of essential foodstuffs.
