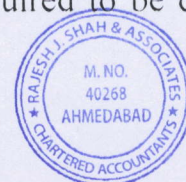
Limited Review Report to the Board of Directors of Omkar Pharmachem Limited for the quarter and half year ended on 30th September, 2020



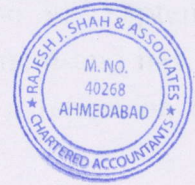
