# Bihar records 54.26% turnout in first phase of Assembly polls

PRESS TRUST OF INDIA Patna/New Delhi, October

THE FIRST PHASE of polling for the Bihar assembly elections passed off peacefully on Wednesday as an estimated 54.26% of nearly 2.15 crore eligible voters exercised their franchise, marginally lower than in 2015, as the coronavirus scare failed to impact the turnout.

The polls were held in 71 constituencies spread across 16 districts amid tight security and strict Covid-19 reg-

the raging Covid-19 pandemic and the poll time increased by an hour till 6 pm to allow suspected or confirmed coronavirus patients to vote in the last hour.

Polling went beyond 6 pm in some constituencies, while the voting hours were curtailed in Naxal-affected areas and ended at 4 pm after beginning at 7 am. Out of the 16 districts which went to polls, 12 are hit by Left-wing extremism, a senior poll panel official said.

"And out of the 12, four are considered as extreme Left-Wing affected," the official said in Delhi, expressing satisfaction at the smooth conduct of the exercise.

Of the nearly 2.15 crore electors eligible to exercise

the franchise, 1.12 crore were male, 1.01 crore female and 599 were categorised as third gender, according to data provided by the Election Commission.

As many as 1,066 candidates are in the fray in the first phase of the poll.

The prominent candidates whose electoral fate has been locked in the EVMs are Shreyasi Singh, a CWG gold medallist shooter, and six members of the outgoing cabinet -- Prem Kumar (Gaya Town), Vijay Kumar Sinha (Lakhisarai), Ram Narayan Mandal (Banka), Krishnanandan Prasad Verma (Jehanabad), Jaikumar Singh (Dinara) and Santosh Kumar Nirala (Rajpur).

**Deputy Election Commis**sioner in-charge of EVMs said in Delhi that the functioning of electronic voting machines was "very satisfactory" during the polling.

A minuscule 0.22% of the total 41,689 ballot units, 0.25 per cent of the total 31,371 control units and 1.28% of the total 31,371 paper trail machines were replaced due to malfunctioning, the officer said.

In 12 polling stations of Jamui, the poll timing was increased by one hour due to the delay in replacing the faulty machines, he said. One control unit and at

least one ballot unit makes for one EVM. Deputy Election Commis-

sioner in charge of Bihar Chandra Bhushan Kumar said in Delhi that overall cash

seizure in Bihar so far stood at ₹46.11 crore including foreign currency worth ₹89.30 lakh.

Across all 16 districts that went to poll on Wednesday, voters were seen queuing up at polling stations since early morning and Covid-19 norms were largely followed with people wearing masks and maintaining a safe dis-

tance from each other. At a polling station in Jalpura village of Bhojpur district, there were not many voters around 3.15 pm when a PTI reporter went to cast his ballot, but plastic hand gloves were strewn all around, used and discarded by electors.

Hand sanitisers were kept at the entrance and the exit gates of the booth. Some people, however, were seen without a face mask.

"We have hand gloves, but some people are refusing to wear," said Angad Kumar, the presiding officer of one of the four booths at the polling station. A 55-year-old polling agent died of heart attack in Nawada district. Officials said Krishna Singh was deployed at booth number 258 in Foolawa village of Hisua assembly constituency.

They said Singh complained of severe heart pain and was rushed to the Sadar Hospital where doctors declared him dead.

As many as 159 people were detained as a preventive measure during the polling, the election panel said.

To contain onion prices, the Centre last week imposed stock holding limit on retail and wholesale traders till December 31 to improve the domestic availability of the key kitchen staple and provide relief to consumers.

विदेश सचिव हर्षवर्धन श्रृंगला गुरुवार से एक सप्ताह के लिए तीन देशों फ्रांस, जर्मनी और ब्रिटेन की यात्रा पर जाएंगे। यात्रा के दौरान बहुपक्षवाद और एक स्वतंत्र, खुले तथा समावेशी हिंद-प्रशांत क्षेत्र समेत कई महत्त्वपूर्ण मुद्दों पर चर्चा होगी। विदेश मंत्रालय ने बताया कि श्रंगला की इन तीन देशों की यात्रा 29 अक्तूबर से चार नवंबर तक चलेगी और यह कोरोना विषाणु महामारी द्वारा उत्पन्न बाधाओं के बावजूद भारत की निरंतर अंतरराष्ट्रीय भागीदारी और कटनीतिक पहुंच का हिस्सा है। मंत्रालय ने बताया, 'भारतीय प्राथमिकताओं जैसे मजबूत बहुपक्षवाद, संयुक्त राष्ट्र सुरक्षा परिषद में उसका आगामी गैर-स्थायी कार्यकाल और मुक्त- खुले तथा समावेशी हिंद-प्रशांत क्षेत्र के लिए उसकी प्रतिबद्धता पर चर्चा की जाएगी।'

मिल सके। इस बीच, मुख्तार के भाई गाजीपुर से बसपा सांसद अफजाल अंसारी ने इसे न्यायिक हिरासत में मुख्तार की हत्या की साजिश का सब्दत करार देते हुए आरोप लगाया है कि उनके भाई के खिलाफ यह षड्यंत्र माफिया से राजनेता बने भाजपा विधान परिषद सदस्य बजेश सिंह को इलाहाबाद में हए हमले

के एक मामले में बचाने के मकसद से रचा जा रहा है। अलका 2005 में गाजीपुर के भावरकोल इलाके में हुए सामृहिक हत्याकांड में मारे गए तत्कालीन भाजपा विधायक कृष्णानंद राय की पत्नी हैं। इस मामले में मऊ से बाहबली बसपा विधायक मुख्तार अंसारी का नाम मुख्य आरोपी के तौर पर सामने आया था। हालांकि, उन्हें व सात अन्य आरोपियों को विशेष सीबीआइ अदालत ने पिछले साल जुलाई में बरी कर दिया था।
