#### **KYC Updation**

Please note that your folio is still not KYC compliant. SEBI has mandated, as per the communication below, to withhold dividends until the folio is KYC compliant. Thereafter, dividends will be credited in electronic mode only, effective from April 1, 2024.

Kindly ensure to update KYC on or before the aforementioned date to continue receiving dividends.

#### SEBI issued a directive via mail to RTA on January 17, 2024.

SEBI, through its circular dated November 3, 2021 (subsequently amended by circulars dated December 14, 2021, March 16, 2023, and November 17, 2023), mandated that security holders (holding securities in physical form), whose folio(s) do not have PAN or Choice of Nomination or Contact Details or Mobile Number or Bank Account Details or Specimen Signature updated, shall be eligible for any payment, including dividends, interest, or redemption, only through electronic mode with effect from April 1, 2024, upon furnishing all the aforementioned details entirely.

In this regard, the company has prominently displayed the aforementioned requirements on the website of the Company (www.greenpanel.com) as directed by SEBI. We hereby notify the respective security holders about folios that are incomplete regarding PAN or Choice of Nomination or Contact Details or Mobile Number or Bank Account Details or Specimen Signature by providing the following message:

- 1. In case of non-updation of PAN or Choice of Nomination or Contact Details or Mobile Number or Bank Account Details or Spemen Signature in respect of physical folios, dividends/interest, etc., shall be paid only through electronic mode with effect from April 1, 2024, upon furnishing all the details in entirety.
- 2. If a security holder updates the PAN, Choice of Nomination, Contact Details including Mobile Number, Bank Account Details, and Specimen Signature after April 1, 2024, then the security holder would receive all the dividends/interest, etc., declared during that period (from April 1, 2024, till the date of updation) pertaining to the securities held after the said updation automatically.
