# NCW refutes claims in Prajwal case

New Delhi: The National Commission for Women has refuted the claim that 700 women have come forward to submit complaints to it in the sexual abuse case against J.D. (S) MP Prajwal Revanna. The commission has said that no victim has come to the commission to register a

complaint against Revanna, and one woman complainant who reached out to the women's body alleged that she was forced to register a fake complaint against the J.D. (S) leader.

The commission has disclosed that the action taken report sent by the authorities in Karnataka, in response to



the letter of the NCW after it took cognisance of the matter, shows that two cases have been registered in the state based on complaints of sexual abuse by the victims, alongside an additional complaint filed for abduction by a relative.

However, no victim has come forward to register a

complaint with the commission in this case.

"One woman complainant came to the commission to register a complaint against three individuals dressed in civil uniform, allegedly introducing themselves as Karnataka Police officials and forcing her to give a false complaint in this case," the NCW claimed.

## Court adjourns Revanna bail plea hearing to May 13

Bengaluru: A special court for elected representatives on Thursday adjourned to Monday the hearing on the bail petition filed by J.D. (S) M.L.A. H.D. Revanna, who was arrested on charges of kidnapping a woman from KR Nagar in Mysuru district last month.

Meanwhile, SIT on Thursday detained four men from KR Nagar in connection to the kidnap case. SIT sources said the men had helped Satish Babamma, one of the arrested suspects, in taking the woman to a secret place and keeping her in confinement between April 29 and May 5. The four were questioned at CID headquarters. Revanna's counsel CV Nagesh argued in the court that the woman was not kidnapped and that SIT has wrongly invoked IPC sections in the case.

"In the police complaint filed by the woman's son, it is mentioned that she was taken out of her home by lying to him... If someone takes out a woman from her home by lying to her son, it does not amount to kidnapping. There was no force used in taking her out. Nor is it mentioned in the complaint that Revanna had cheated. Still, Revanna has been named as accused number one in the FIR," Nagesh said.

Additional special public prosecutor Jayna Kothari, however, argued that the woman had been kidnapped to stop her from filing a complaint against Revanna's son Prajwal and others. "The statement made by the woman mentions the role of Revanna in the kidnap. The woman's son also mentions that his mother was forcibly taken out from her home and this is nothing but a kidnap case," he said.
