

Concerning the Current status of the Corporate Debtor, we would like to inform you that the Corporate Debtor M/s. Dharani Sugars and Chemicals Limited was under the liquidation process vide order no. **IA/(IBC)/1023(CHE)/2023 in IBA/976/2019 dated 28th June 2023** and the matter was appealed by the erstwhile promoter to the Hon'ble Supreme Court, it has been ordered for the stay of liquidation process till the next hearing through the interim order and the same was intimated to Stock Exchanges vide letter no. LIQ/MSK/DSCL/2023-172 dated 08th August, 2023.

Also, concerning the assignment of debt to NARCL, the fact of debt assignment has been intimated vide letter no. LIQ/MSK/DSCL/2023-188 dated 20th October, 2023.

Further, the Liquidation order doesn't state about the delisting of the securities in the exchange, and the CD has not yet decided to delist the shares in the both NSE and BSE, as there is a chance for a revival of the same through "Scheme of arrangement" u/s 230 of Companies Act OR through IBC OR through the sale of Corporate Debtor as a going Concern.

The appeal of the promoters was heard by Supreme Court on 06.11.2023 and a direction in case no. 5308/2023 has been given to the Liquidator, to convene a COC meeting and to report the progress of the same in the next hearing. The same was heard on 04.01.2024 and the matter was posted for the next hearing on March 2024. Subsequently, the order was heard and disposed of on 18th March 2024.

The order passed by the Supreme Court of India vide order no.5308/2023 dated 18.03.2024 directed to set aside the Liquidation order as well as the judgment/order dated 27.06.2023 passed by the NCLT Chennai Bench-1 and remit the matter to the NCLT, to examine and follow the procedures established by law in terms of section 12A of IBC, 2016.

A copy of the Supreme Court order has been attached for your reference.
