

## SCRUTINIZER'S REPORT ON THE POSTAL BALLOT PROCESS CONDUCTED THROUGH E-VOTING

[Pursuant to Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014]



Sub: Scrutinizer's Report on the Postal Ballot Process through remote E-voting for passing of the Resolution as set out in the Postal Ballot Notice dated 10<sup>th</sup> November, 2023 of HLV Limited.

I, Raghunath Bhandari, Proprietor of M/s. R. Bhandari & Co., Company Secretaries (COP No. 15381), having office at Office No. 402 - 4th Floor, "A" Wing, Pushp Vinod No. 2, S. V. Road, Borivali (West), Mumbai – 400 092 was appointed as a Scrutinizer by the Board of Directors of the Company at its meeting held on Friday, 10th November, 2023 to conduct and scrutinise postal ballot process through remote evoting for passing of the resolution contained in the Postal Ballot Notice dated 10th November, 2023 as per the provisions of Sections 108 and 110 of the Companies Act, 2013 ('the Act') read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, ("SEBI LODR") and Secretarial Standards on General Meetings (SS-2) issued by the Institute of Company Secretaries of India, and General Circular No. 14/2020 dated 8th April. 2020, General Circular No. 17/2020 dated 13th April, 2020, General Circular No. 22/ 2020 dated 15th June, 2020, General Circular No. 33/2020 dated 28th September, 2020, General Circular No. 39/2020 dated 31st December, 2020, General Circular No. 10/2021 dated 23rd June, 2021, General Circular No. 20/2021 dated 8th December, 2021, General Circular No. 3/2022 dated 5th May, 2022, General Circular No. 11/2022 dated 28th December, 2022 and General Circular No. 09/2023 dated 25th September, 2023 respectively issued by the Ministry of Corporate Affairs (collectively referred to as "MCA circulars").

In this regard, I submit my report as under:

- 1. The management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013 and Rules made thereunder and the applicable provisions of the SEBI LODR and MCA circulars issued by the MCA, for passing of resolutions through the mechanism of Postal Ballot through remote evoting as stated in the Postal Ballot Notice dated 10<sup>th</sup> November, 2023. My responsibility as a Scrutinizer for Postal Ballot Process through e-voting is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolution, based on the reports generated from the e-voting system provided by National Securities Depository Limited ("NSDL"), the agency engaged by the Company to provide remote e-voting for the Postal Ballot.
- 2. As per the confirmation received from the Company, the Postal Ballot Notice dated 10<sup>th</sup> November, 2023 along with explanatory statements setting out material facts pursuant to Section 102 of the Companies Act, 2013 was dispatched electronically on Wednesday, 29<sup>th</sup> November, 2023 to members who had registered their Email-ID's with Company/Company's Registrar and Share Transfer Agent (RTA)/Depositories/Depository Participant(s) and furnished the same with M/s. MCS Share Transfer Agent Limited, the Registrar and Share Transfer Agent (RTA) of the Company and the same was hosted on the website of the Company and NSDL.
- 3. Pursuant to the Clause (v) of sub rule 4 of the Rule 20 and sub-rule 3 of Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time and MCA circulars, the Public Notice for the Postal Ballot Process through remote E-voting were published in "Free Press Journal" (English Newspaper) and "Navshakti" (Marathi Newspaper) on Thursday, 30th November, 2023. The notice published in the newspapers carried the required information as prescribed in Sub Rule 4(v) (a) to (h) of the said Rule 20.
- The voting rights were reckoned as on Friday, 24th November, 2023, being the Cut-off date for the purpose of deciding the entitlement of Members for the Postal Ballot evoting.
- 5. In terms of the aforesaid Notice, the Postal Ballot E-voting was kept open for 30 (Thirty) days from Saturday, 02<sup>nd</sup> December, 2023,09:00 a.m. (IST) till Sunday, 31<sup>st</sup> December, 2023, 05:00 p.m. (IST) as prescribed under the Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014. Members were required to cast their votes electronically conveying their assent or dissent in respect of the Special Resolution on the remote e-voting platform provided by NSDL.
- 6. After completion of remote e-voting, the votes casted by the members were unblocked by me in the capacity of Scrutinizer in the presence of two witnesses, Mr. Kumar Barot and Ms. Bhavna Joshi who are not in employment of the Company and the evoting results report downloaded from the website of NSDL.
- 7. It is observed that 463 Members casted their votes through remote e-voting.
- 8. A summary of the Postal Ballot results and votes casted through remote e-voting with respect to the Special Resolution as set out in the Postal Ballot Notice dated 10<sup>th</sup> November, 2023 are as under:
