Titled 'All Time Favourites for Children", the stories have been curated and selected by the author himself. The narration is by Anuj Datta. Bond said audiobooks can be like oral storytelling and stimulate a child's interest in reading.

"Sometimes a child is reluctant to make the effort to start reading a book. If it's beingreadtothem, either the book is on audio or somebody is reading from one, it helps to create interest. Once that interest

develops, the young reader very often will go on to reading books on his or her own," Bond told PTI. "I would call it a stimulus, a catalyst for the whole art of reading," he added.

Talking about his childhood, Bond said he began to read at a pretty young age. "My father used to tell me stories mostly about history. I was an early reader but some kids are not. They come a bit late to books. So, audiobooks fit in very well there in their early years," he said.
