MORETHAN 900 cartons with al-cohol worth Rs 44 lakh hidden in a vehicle resembling a cement mixer were seized in Vadodara on mixer were seized in Vadodaroon Tuesday, said police. The driver of the vehicle has been booked and arrested, officials added, while another accused is on the run. The Local Crime Branch (LCB) O'Vadodara Ruar Police received a tip off that a cement concrete mixer passing through the Vadodara-Ahmedabad express-way was transporting several car-

Vadocara-Annecadade express-way was transporting several car-tons of alcohol. When the vehicle, bearing the brand name of a pop-ular cement company arrived, the officials conducted a thorough check and discovered that the container was custom-made to
