Pursuant to Regulation 30 read with Para A of Part A of Schedule III of Listing Regulations, we hereby inform you that the Company has received Order from the Office of the Principal Commissioner of Central Tax, Hyderabad GST Commissionerate, Hyderabad confirming a demand of Rs.14.29 lakhs plus interest thereon and penalty of Rs.1.67 lakhs under Section 73 of the Central Goods and Services Tax Act, 2017 and Telangana Goods and Services Tax Act, 2017 for excess input tax credit availed in 2018-19. The Company is in the process of filing an appeal against the said Order.

There is no material impact on the financials, operations or other activities of the Company due to this penalty.
