Dear Sir,

- 1. I, G. Nagendrasundaram, Chartered Accountant in Practice, has been appointed as a scrutinizer by the Board of Directors of Healthy Investments Limited ("the Company") for the purpose of:
  - Scrutinizing the remote e-voting process under the provisions of Section 108 of the Companies Act, 2013 ("Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended ("Rules") and

  - (i) The Company availed the services of National Securities Depository Limited (hereinafter referred to as the "Service Provider") to offer the electronic voting facility to its shareholders. The e-voting facility was offered and kept open by the Company to its Shareholders during the period from 17<sup>th</sup> September, 2023 at 10.00 A.M. to 19<sup>th</sup> September, 2023 at 5.00 P.M. On 20<sup>th</sup> day of September 2022, the votes cast through e-voting facility were duly unblocked by me in the capacity of the Scrutinizer in the presence of 2 persons who were present as witnesses. I have downloaded the data of e-voting from NSDL. A Final report was tabulated by me and the data regarding the final E-Voting was diligently scrutinized and reconciled with the records maintained by the Company.

- (ii) The Company provided the Poll facility at the venue to the shareholders who attended the meeting and did not participate in the E-voting facility to cast their votes through poll at the AGM.
- (iii) Subsequent to the completion of voting process at the 41<sup>st</sup> AGM, the votes cast by the shareholders at the AGM were diligently scrutinized by me.
