In continuation of the said disclosure, we write to inform you that the Company has filed the application for clarification before Hon’ble Supreme Court and the matter was heard on April 22, 2024. After hearing the submissions made on behalf of the Company, the Hon’ble Court has, vide order signed on 24.04.2024, clarified that fifty percent of the amount awarded, amounting to approx. Rs. 98.00 Lakhs, to the next kin of deceased, as per the impugned order, be released to the legal representatives of the deceased from the deposit of Rs. 5.00 crores (Rupees Five Crores only) to be made by the Company. It is pertinent to mention here that the amount to be deposited by the Company shall be without prejudice to the rights and contentions of the parties and subject to outcome of the appeal/ further orders of the Hon’ble Court. The stay granted by the Hon’ble Supreme court continues as on today.
