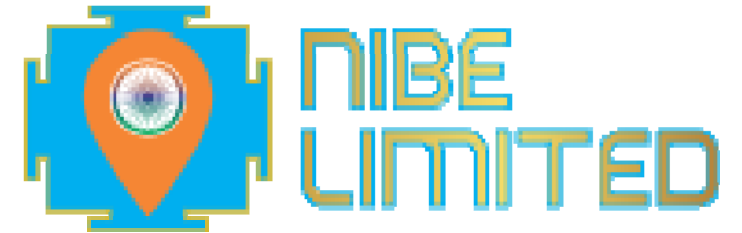

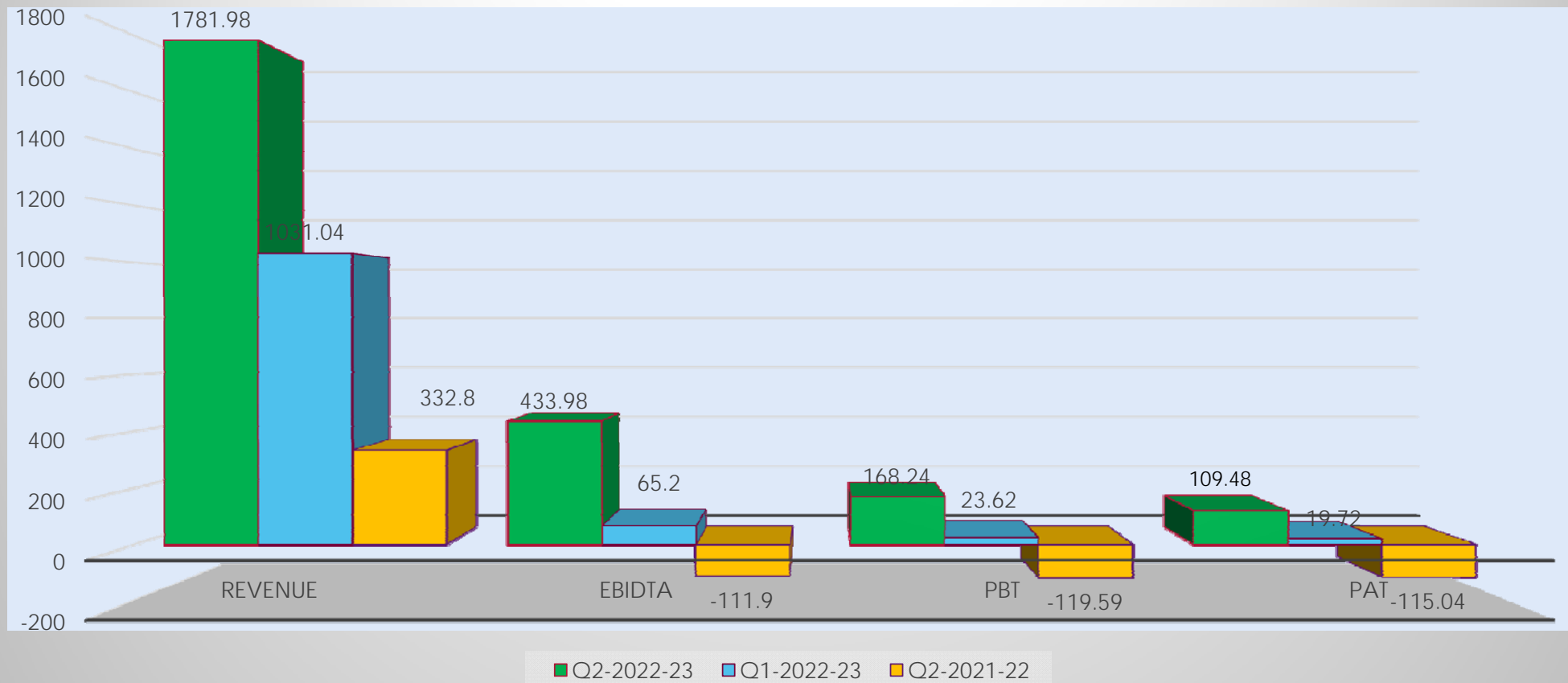

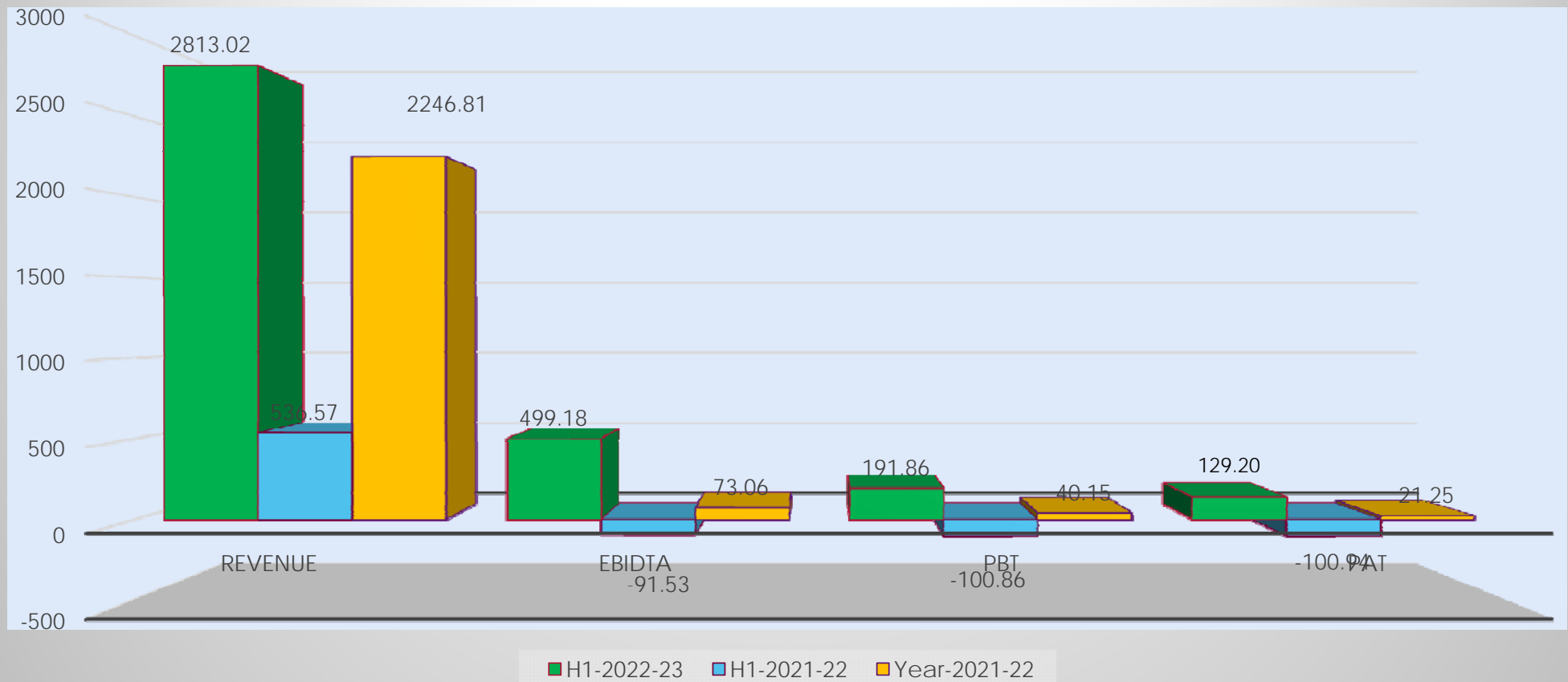
FINANCIAL HIGHLIGHTS (Q2-2022-23)

Financial Performance(Amt in Rs. Lacs)

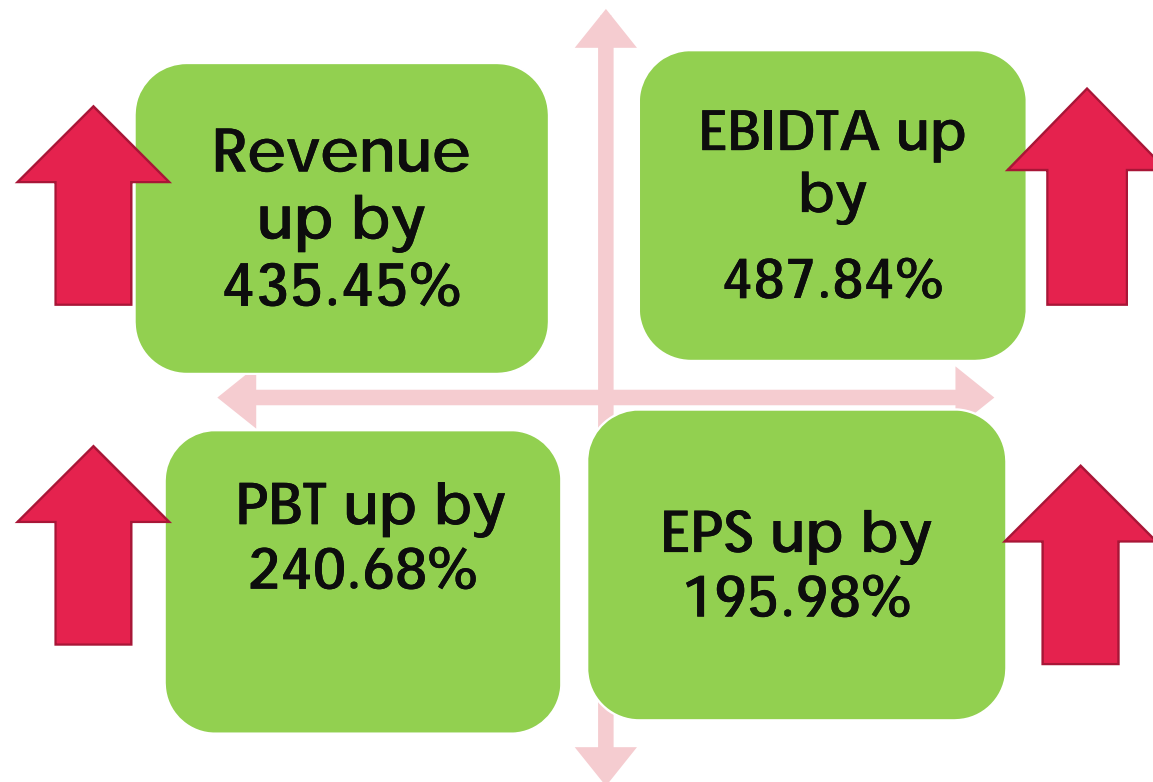


FINANCIAL HIGHLIGHTS (H1-2022-23)

Financial Performance(Amt in Rs. Lacs)

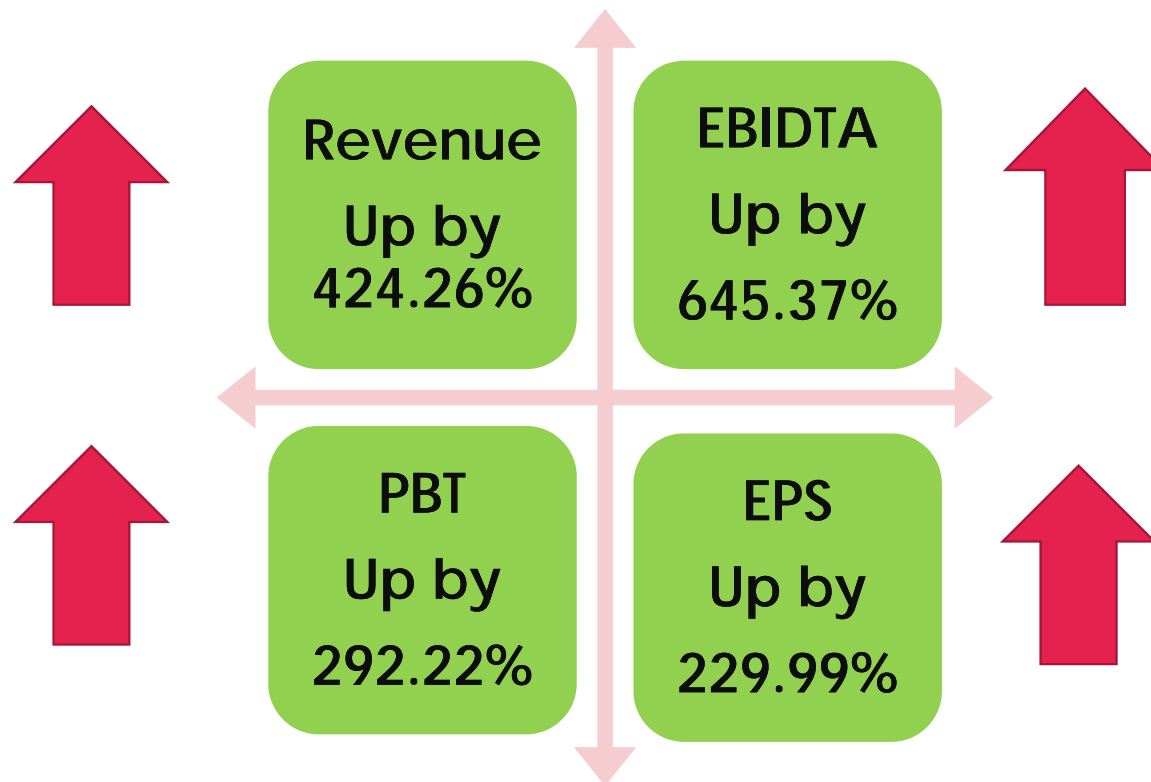


COMPARATIVE ANALYSIS(Q2- 2022-23)
