# Sub: <u>Scrutinizer's Report on Postal Ballot voting by way of remote e-voting in respect of passing of the resolution set out in the Postal Ballot Notice dated 22.02.2024</u>.

Dear Sir,

I, A. N. Kukreja, Proprietor, A. N. Kukreja and Co, Company Secretaries, was appointed as of Oil of Directors the Board India Limited (CIN: scrutinizer by L11101AS1959GOI001148 (the Company) on 13.02.2024 for the purpose of scrutinizing the Postal Ballot voting conducted by way of remote e-voting process in a fair and transparent manner and to ascertain the requisite majority on the resolution contained in the Postal Ballot Notice dated 22.02.2024, issued in accordance with MCA circulars, including General Circular Nos.14/2020 dated 08.04.2020, 17/2020 dated 13.04.2020, 22/2020 dated 15.06.2020, 33/2020 dated 28.09.2020, 39/2020 dated 31.12.2020, 10/2021 dated 23.06.2021, 20/2021, dated 08/12/2021, 3/2022 dated 05.05.2022, 10/2022 dated 28.12.2022 and 09/2023 dated 25.09.2023 and other relevant circulars, as amended from time to time, issued by the Ministry of Corporate Affairs ('MCA') (hereinafter collectively referred to as 'MCA circulars') and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended from time to time, (SEBI Listing Regulations), Secretarial Standard on General Meetings ('SS-2') issued by the Institute of Company Secretaries of India and other applicable provisions of the Act, Rules, circulars and notifications issued thereunder (including any statutory modification(s) or re-enactment thereof for the time being in force and as amended from time to time), guidelines prescribed by the Ministry of Corporate Affairs. Government of India.



I submit my report as under:

- 1. The said appointment as Scrutinizer is under the provisions of Section 110 of the Companies Act 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended.
- 2. The Management of the Company is responsible to ensure compliance with the requirements of (i) the Companies Act, 2013 and Rules made there under, (ii) MCA circulars and (iii) SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 (LODR) relating to e-voting on the resolution contained in the Postal Ballot Notice, Secretarial Standard on General Meetings ("SS 2") issued by the Institute of Company Secretaries of India and for ensuring a secured framework and robustness of electronic voting system.
- 3. My responsibility as Scrutinizer is restricted to making Scrutinizer's Report of the votes cast by the members on the resolution contained in the postal ballot notice dated 22.02.2024 based on the reports generated from National Securities Depository Limited (NSDL), the authorized agency engaged by the Company to provide e-voting facility for e-voting ballots received till the time fixed for closing of e-voting process.
- 4. The Company had appointed National Securities Depository Limited (NSDL) the service provider for providing the facility of remote e-voting to the members of the Company. The service provider has provided a system for recording the votes of the shareholders electronically.
- 5. The members of the Company as on the "cut-off date" i.e., 20.02.2024 were entitled to avail facility of remote e-voting on the resolution set out in the Notice of Postal Ballot dated 22.02.2024.
- 6. On 23.02.2024, the Company completed dispatch of Postal Ballot Notice through email to its members whose names appeared in the Register of Members/List of Beneficial owners received from NSDL/CDSL as on the cut-off date i.e. 20.02.2024 and who had registered their email address with the company/ depositories.
- 7. As required under sub-rule 3 of Rule 22 of Companies (Management and Administration) Rules, 2014, advertisements were published by the Company in "Business Standard" (English newspaper) and "Amar Asom" (vernacular newspaper) on 24.02.2024 informing about the completion of dispatch/electronic transmission of postal ballot notice to the members.
- 8. The members of the Company had to cast their votes on the resolution only by remote e-voting facility on the designated website of NSDL



- 9. The remote e-voting period commenced on 26<sup>th</sup> February, 2024 at 9:00 A.M. and ended on 26<sup>th</sup> March, 2024 at 5:00 P.M. After the time fixed for closing of the e-voting, the electronic voting system was blocked by NSDL.
- 10. I had monitored the process of electronic voting (i.e., remote e-voting) through the scrutinizer's secured link provided by NSDL through its designated website.
- 11. Post completion of remote e-voting period at 5:00 P.M. on 26<sup>th</sup> March, 2024, votes cast were unblocked in the presence of two witnesses who are not in the employment of the Company. Their confirmation in writing is attached as Annexure I.
- 12. After ascertaining the votes cast by e-voting/ remote e-voting, I hereby submit the result of e-voting on the resolution contained in the Postal Ballot Notice dated 22.02.2024, as under:
