I, Umesh Ved, Proprietor of M/s. Umesh Ved & Associates, Company Secretaries, Ahmedabad, was appointed as Scrutinizer for the purpose of scrutinizing the Remote E-Voting process and voting at the Annual General Meeting ("AGM") pursuant to Section 108 & 109 of the Companies Act, 2013 read with Rule 20 of Companies (Management and Administration) Rules, 2014, as amended on the resolutions contained in the Notice to the 24th AGM of the Members of "TGB Banquets and Hotels Limited" (the Company) held on Friday, the 29<sup>TH</sup> September, 2023 at 11:00 a.m. held at the Registered Office of the Company situated at "The Grand Bhagwati", Plot No. 380, S.G. Road, Bodakdev, Ahmedabad – 380054.

My responsibility as a scrutinizer for the voting process is restricted to preparing a Scrutinizer's Report of the votes casted "in favour" or "against" the resolution(s) based on the reports generated from the Remote e-voting system provided by National Securities Depository Limited (the Agency/ service provider) and the Polling at the AGM.

#### I submit my report as under:

- i. After the time fixed for closing of the poll by the Chairman, one ballot box kept for polling was locked in my presence with due identification marks placed by me.
- ii. The locked ballot box was subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company.

- iii. The shareholders of the Company holding shares as on the "cut-off" date Friday  $22^{nd}$  September, 2023 were entitled to vote on the proposed resolutions as set out in Item Nos. 1 to 3 in the Notice of the  $24^{th}$  AGM of TGB Banquets and Hotels Limited.
- iv. The facility provided for Remote E-Voting commenced from 9.00 A.M. on Tuesday, the  $26^{th}$  September, 2023 and ended on 5.00 P.M. on Thursday, the  $28^{th}$  September, 2023. The Remote E –voting facility was blocked thereafter.
