Opinion

We have audited the accompanying "Statement of Financial Results of **ARIHANT'S SECURITIES LIMITED** (the "Company") for the Quarter and Year ended March 31, 2024, (the "Statement"), being submitted by the Company pursuant to the requirements of Regulation 33 & 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations ,2015, as amended (the "Listing Regulations").
