**Re: Submission of Financial Statement for FY-2018-19 in XBRL Format**

Please note –

- The Company filed its Financial Results (Reg. 33 of LODR) for the Financial Year 2018-19 and 4th Quarter thereof, on 18-May-19. BSE in its communication dated 30-May-19 (**Link** : <http://www.sumedhafiscal.com/downloads/Comp/bse-email-dated-30-May-19.pdf>) advised the Company to submit revised Financial Results in accordance with **NBFC (Division III) format of Companies Act, 2013**. The Company complied with the requirement, as advised, on 11-Jun-19.
- MCA by its **Notification G.S.R. (E) dated 11-Oct-18** required **NBFCs** to follow the Indian Accounting Standard (IND-AS) as prescribed in Schedule – III of the Companies Act, 2013, as applicable to NBFCs, for submission of Financial Statement Statements (to MCA). (**Link** : [https://mca.gov.in/Ministry/pdf/NotificationScheduleIII\\_12102018.pdf](https://mca.gov.in/Ministry/pdf/NotificationScheduleIII_12102018.pdf))
- However MCA did not issue the required Taxonomy for preparation and submission of Financial Statements by an NBFC. Therefore the Company could not submit the Financial Statement for FY-2018-19 and kept on raising the issue with MCA web-portal for a solution.

- MCA did not issue the format for NBFCs but extended the time-limit for submission thereof (for FY-2018-19), several times. Lastly, by its **General Circular No. 12/2020 dated 30-Mar-20 MCA declared Fresh Start Scheme, 2020** for submission of various pending returns/documents by Companies (including Taxonomy for XBRL), **by 30-Sep-20** (**Link** : [http://www.mca.gov.in/Ministry/pdf/Circular12\\_30032020.pdf](http://www.mca.gov.in/Ministry/pdf/Circular12_30032020.pdf)). The limit was extended upto **31-Dec-20** vide **MCA's General Circular No. 30/2020 dated 28-Sep-20**. (**Link** : [http://www.mca.gov.in/Ministry/pdf/GeneralCircularNo.30\\_28092020.pdf](http://www.mca.gov.in/Ministry/pdf/GeneralCircularNo.30_28092020.pdf)).
- The Company accordingly, **filed the pending Financial Statement for FY-2018-19 (in XBRL format) to MCA**, as per the said MCA Scheme. MCA has acknowledged the submission and also approved the same. Attached the MCA Receipt & approval.
