

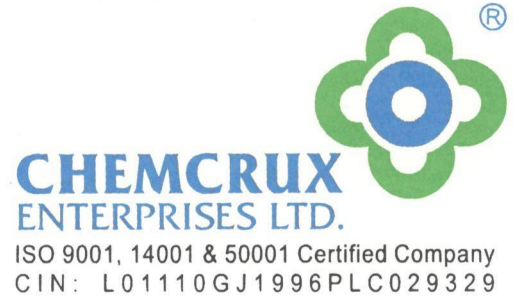

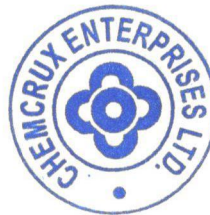

NOTICE FOR CLOSURE OF TRADING WINDOW

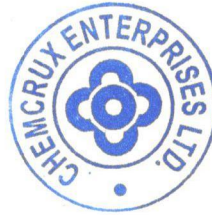
