My responsibility as a scrutinizer is to ensure that the voting process both through remote E voting as well as by E voting at Extra Ordinary General Meeting is conducted in a fair and transparent manner and to provide a consolidated Scrutinizer's Report of the votes cast "In favour" or "Against" the resolutions contained in the Notice to the Chairman or his authorized representative, based on the reports generated from system of Link Intime India Private Limited ("LIIPL"), the service provider.

The Notice convening Extra Ordinary General Meeting dated 5th February, 2024 along with statement setting out material facts under Section 102 of the Act were sent to the Shareholders through electronic means to those shareholders whose emails address were registered with the Company / depositories.

Voting rights were reckoned as on Thursday, 7th March, 2024, being the cut-off date for the purpose of deciding the entitlements of members for voting on the resolutions as contained in the notice of Extra Ordinary General Meeting.

The voting period for remote e-voting commenced on Monday, 11th March, 2024 at 9.00 A.M. (IST) and concluded on Wednesday, 13th March, 2024, at 5.00 p.m. (IST) and thereafter the LINKINTIME e-voting platform was blocked and then re-opened during the Extra Ordinary General Meeting.
