सिन्हा ने पत्र में लिखा कि मैं यह पत्र बहत दुखी मन से लिख रहा हूं। आपकी सरकार ने उच्च शिक्षा पर अकल्पनीय और अनापेक्षित हमला किया है। आपकी तानाशाहीपूर्ण, अदूरदर्शी और घोर राजनीतिक स्वार्थपूर्ण नीतियों के कारण दिल्ली विश्वविद्यालय के 12 कॉलेज कई महीनों से अप्रत्याशित वित्तीय संकट से गुजर रहे हैं। इन कॉलेजों को दिल्ली सरकार से मिलने वाली
