Dear Sir/Madam,

There is further to our intimation dated April 18, 2021 giving intimation of petition filed under section 9 of Insolvency and Bankruptcy Code, 2016 ('Code') by M/s. Koncepts Interior, Operational Creditor of the Company, before the Hon'ble National Company Law Tribunal -Mumbai Bench ('Hon'ble NCLT') seeking initiation of Corporate Insolvency Resolution Process (CIRP) against the Company, and subsequent intimations including latest one dated August 03, 2023. As intimated on August 03, 2023, the matter was argued on August 03, 2023 in Court No. NCLT-5 and it was reserved for orders of Hon'ble NCLT and further the said matter was listed on October 09, 2023, in Court No. 5, NCLT, Mumbai for consideration but it was not taken up. The matter was again listed on November 23, 2023 and it was informed to the Hon'ble court that the said matter was reserved for order by the former Bench but due to non-pronouncement and reconstitution of Benches, the matter had been listed for de-novo hearing but in view of communication dated September 25, 2023 received from the Registrar, NCLT, Principal Bench, orders would be pronounced by the former Bench. The said matter was got again listed on March 05, 2024 and the Hon'ble Bench had ordered that the matter has to be reheard before the reconstituted Bench and was listed on April 04, 2024. Today, the matter got adjourned to April 18, 2024.
