JERUSALEM: Over the last five months, Israel has killed thousands of Hamas fighters, destroyed dozens of their tunnels and wreaked unprecedented destruction on the Gaza Strip

But it still faces a dilemma that was clear from the start of the war and will ultimately determine its outcome: It can either try to annihilate Hamas, which would mean almost certain death for the estimated 100 hostages still held in Gaza, or it can cut a deal that would allow the militants to claim a historic victory.

Either outcome would be weeks. excruciating for Israelis. Either would likely seal an ignominious end for Prime Minister Benjamin Netanyahu's long political career. And either might be seen as acceptable by Hamas, which valorizes martyrdom.

UN REPORT 'Over 8,500 migrants died worldwide last year'

GENEVA: A total of 8,565 migrants died on land and sea routes worldwide last year, the UN migration agency said Wednesday, a record high since it began tallying deaths a decade ago.

The International Organisation for Migration (IOM) said the biggest increase in deaths last year was on the treacherous Mediterranean Sea crossing, to 3,129 from 2,411 in 2022. However, that was well below the record 5,136 deaths recorded on the Mediterranean in 2016 as huge numbers of Syrians. Afghans and others fled conflicts toward Europe. IOM said the total number of deaths among migrants in 2023 was nearly 20 per cent more than in 2022.


