An Explanatory Statement pursuant to Section 102 of the Act and other applicable provisions, pertaining to the below-appended resolution setting out the material facts and the reasons thereof, is annexed herewith for your consideration.

In compliance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the LODR Regulations") and pursuant to the provisions of Sections 108 and 110 of the Act read with the rules framed thereunder and the MCA Circulars, the manner of voting on the proposed resolution is restricted only to e-voting i.e., by casting votes electronically instead of submitting postal ballot form. Accordingly, the Postal Ballot Notice and instructions for e-voting are being sent only through electronic mode to those members whose email address is registered with the Company / Depository Participant ("DP").

The Board has appointed Mr. Shivaram Bhat (Membership No. A10454, COP 7853) Practicing Company Secretary, as the scrutinizer ("Scrutinizer") for conducting the Postal Ballot / e-voting process in a fair and transparent manner.

In compliance with the provisions of Sections 108 and 110 of the Act read with Rule 20 and 22 of the Management Rules, Regulation 44 of the LODR Regulations, and SS-2, the Company has provided e-voting facility to its members to cast their votes electronically. The detailed procedure with respect to e-voting is mentioned in this Notice. For this purpose, the Company has engaged the services of Link Intime India Private Limited ("LIIPL") as the agency to provide e-voting facility through their website viz. <a href="https://instavote.linkintime.co.in">https://instavote.linkintime.co.in</a>.

# EXPLANATORY STATEMENT [Pursuant to Sections 102 and 110 of the Companies Act, 2013]

The following Explanatory Statement sets out all material facts relating to the business mentioned in the accompanying Notice dated 21st March 2024.

#### Item No. 1

Mr. Nagesh Pinge (DIN: 00062900) is currently an Independent Director of the Company and Chairman of the Audit Committee.

Mr. Pinge was appointed as an Independent Director of the Company by the Members at the 51<sup>st</sup> Annual General Meeting of the Company held on 8<sup>th</sup> July 2019 for a period of 5 (five) consecutive years commencing from 6<sup>th</sup> May 2019 upto 5<sup>th</sup> May 2024 (both days inclusive) and is eligible for re-appointment for a second term on the Board of the Company.

Based on the recommendation of the Nomination and Remuneration Committee, the Board of Directors, proposed the re-appointment of Mr. Pinge as an Independent Director of the Company for a second term of 5 (five) consecutive years commencing from 6<sup>th</sup> May 2024 upto 5<sup>th</sup> May 2029 (both days inclusive), not liable to retire by rotation, for the approval of the Members by way of a Special Resolution.

Mr. Pinge holds a Bachelors of Commerce degree, is a Chartered Accountant from the Institute of Chartered Accountants of India, a Bachelor of Laws and an Executive Education Program from the Stephen M Ross School of Business of the University of Michigan, USA. He has over 40 years of experience serving large and mid-sized organisations in several sectors in areas of audit, taxation, corporate finance, risk management, corporate governance and corporate advisory. He is serving on the Boards of reputed companies, including being Chairman of the Audit Committees.

The Nomination and Remuneration Committee taking into consideration the skills, expertise and competencies required for the Board in the context of the business of the Company and based on the performance evaluation, concluded and recommended to the Board that Mr Pinge's qualifications and the rich experience of over four decades in the abovementioned areas meets the skills and capabilities required for the role of Independent Director of the Company. The Board is of the opinion that Mr. Pinge continues to possess the identified core skills, expertise and competencies fundamental for effective functioning in his role as an Independent Director of the Company and his continued association would be of immense benefit to the Company.

The Company has in terms of Section 160(1) of the Act received a notice from a Member proposing his candidature for the office of Director. In terms of Regulation 25(8) of the SEBI Listing Regulations, Mr. Pinge has confirmed that he is not aware of any circumstance or situation which exists or may be reasonably anticipated that could impair or impact his ability to discharge his duties. Mr. Pinge has also confirmed that he is not debarred from holding the office of Director by virtue of any SEBI Order or any such authority pursuant to circulars dated June 20, 2018 issued by BSE Limited and the National Stock Exchange of India Limited pertaining to enforcement of SEBI Orders regarding appointment of Directors by the listed companies.

Further, Mr. Pinge has confirmed that he is not disqualified from being appointed as Director in terms of Section 164 of the Act and has given his consent to act as Director in terms of Section 152 of the Act, subject to reappointment by the Members.
