Sub: Regulation 29(2) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011

This is to inform you that vide our letter dated August 24, 2005 the aggregate holding of the Schemes of HDFC Mutual Fund ('the Fund') in "**Savita Oil Technologies Limited**" ('the Company') was 8.63%.

Further, the sale of 89,838 shares on April 18, 2024 (i.e. trigger date) resulted decrease in shareholding by 2.02% as compared to previous disclosure made vide letter dated August 24, 2005.

Accordingly, as on April 18, 2024 the aggregate holding of the Schemes of HDFC Mutual Fund is **6.61%** of the paid up equity share capital of the Company.
